## JUNE 2021 SASKATOON - MQE APPLICATION - CONTINUED

### Eligibility for Member Qualifying Examination (MQE)

- Candidates who have successfully completed a minimum 2,200-hour curriculum-based massage therapy training program will be eligible to participate in the Membership Qualifying Exam.
- Candidates who have successfully completed a course in massage therapy at an educational institute outside of Saskatchewan, which the Education Committee, in accordance with the MTAS bylaws, considers to be the equivalent to the core curriculum currently taught in Saskatchewan schools.

### How to apply for the Member Qualifying Examination (MQE)

- Fill out this application completely. Incomplete applications will be sent back to you UNPROCESSED, with no space reserved.
- Applications will be processed on a first come, first served basis.
- **No applications for the Membership Qualifying Examination will be accepted after May 14<sup>th</sup>.**
- Attach all required supporting documentation:
  - Current CPR Level C and Standard First Aid Certification.
  - Current criminal record check (CRC), incl. vulnerable sector search, dated within the last 6 months.
  - Final year MT school transcripts. **\*\***

**\*\* (School transcripts may be submitted after the application date if not available, however MQE results will not be released until they are received.) The other two documents must accompany your application, otherwise it will be returned to you unprocessed.**

### Important:

- The regular exam fee is \$430.00, incl GST.
- For 2021 the exam is being offered at a subsidized rate of \$215.00 for those already practicing, and free to new graduates, to assist in transitioning therapists into the Association in preparation for the recently announced introduction of legislation for massage therapy.
- Dates, times, and location of the exam are subject to change or cancellation, dependent upon number of candidates.
- If you do not show up for your scheduled exam, a no-show fee of \$430.00 will be processed to the credit card on file. **Initial this box to acknowledge you have read and accepted this stipulation [ ]**.
- **The deadline for applications is May 14<sup>th</sup>, 2021.**
- We cannot guarantee that your written and practical exams will be held on the same day. The schedule will be determined once all applications have been received.
- You may attempt the exam a maximum of three times. For graduates prior to November 1, 2020, the first two attempts will be at the subsidized rate of \$215.00. For graduates November 1, 2020 and later, the first two attempts are offered at no charge. The third and final attempt for all candidates will be at the regular rate of \$430.00 incl. GST.
- As a courtesy to other candidates and our examiners, the exams will start on time. If you are late for your scheduled exam, either written or practical, you will be denied entry and will forfeit your payment and first attempt. **Initial this box to acknowledge you have read and accepted this stipulation [ ]**.
