  - Second payment post-dated no later than January 31<sup>st</sup>, 2024 <u>for \$261.50</u> (\$230.00 membership + \$30.00 administration fee + \$1.50 GST).
- **3.** Three-payment plan <u>for practicing members only (\$493.00 total cost)</u>: An administration fee of \$30.00 + GST is applied to the second and third payments. All cheques must be sent at the same time, with your renewal form. (If paying by credit card, your signature authorizes MTAS to process both payments on the dates specified.)
