# **ADDITION TO WRITTEN REPORT:**

- There has been a question to the office about what happens when a complaint is received.
- When dealing with the media, please remember that MTAS has no control over what the media prints/says.
- Facebook and other social media may be informative and engaging, but all information posted should not necessarily be considered accurate in all circumstances.
- MTAS has a comprehensive complaints and investigation policy and Bylaw in place. Refer to the Bylaws, Section 10, for full comprehension.

- Bylaws are written to protect both the therapist and the patient. We require a written and signed complaint form to fully disclose the nature of the complaint and the person who is asking for the investigation.
- MTAS cannot act on information that is anecdotal or rumour.
- MTAS can, has and will suspend members who may be perceived as being a danger to the public, or in severe conflict with the Code of Ethics or Standards of Practice.
- Since there is currently no legislation in this province, MTAS cannot legally interfere with a police investigation, nor are we privy to any information or resources that the police may or may not be investigating.
- Currently MTAS has the unfortunate duty of advocating on behalf of the professional RMT
  Association, and the protection of the public (the College). We are looking forward to the
  distinction between the two, and when regulation for the Sask. College of Massage Therapists
  comes to fruition.
- **M.** Churchman: "Are there privacy issues with information sharing with other provinces when there is a complaint and our member is suspended or removed? Is that information shared with other provinces if they request it?"
- **L. Green, Executive Director**: "We cannot send out a notice that a member has been suspended or removed from the Association. However, with he CMTA members, we do require membership in good standing. We would not give a good standing report we would reveal that the member had been removed/suspended. In conjunction with the MTAS lawyer, Mark Mulatz, we have recorded all complaints and investigations since long before MTAS was incorporated, and in the event of regulation, if someone tries to access back into the College, that information will be available."
- **G. Woynarski, President:** One thing to remember with the media is that they tweak words. e.g the word "rub". We would never use that word. The media is just trying to get hits on their articles."

<u>Purpose:</u> to promote research literacy, research capacity and knowledge translation.

## Objectives of this Board around research:

- 1. To be visible as a leader in massage therapy research so that we can share resources and expertise among the massage therapy and healthcare communities.
- 2. To strengthen our and your research literacy, capacity and knowledge translation skills so that we can use and do research.

#### Summary of accomplishments in the last four years:

- 1. We have created and developed some pretty cool research literacy activities:
  - research symposium
  - journal clubs

These were centred around improving research literacy.

Research literacy is the ability to read and understand research.

- 2. We have conducted some research:
  - a narrative review of the literature
  - wrote an evidence brief

These were to answer the Ministry of Health's questions about whether there is risk of harm in the practice of massage therapy. In doing so, we overcame decades long barriers to regulation.

3. In the last year, there has been lots of helping out – lots of work with peer reviewing papers, reviewing grants through other organizations that are supportive of massage therapy.

- 4. Also in the last year trying and failing to create some infrastructure for massage therapy research in Canada.
- 5. For the future/moving forward: we have a healthy fund and are going to talk about what to be doing at strategic planning, and make some decisions.
